Subject: NOTICE OF EXPIRY OF TERMS OF OFFICE OF FOUR MEMBERS OF THE AFRICA REGIONAL SCOUT COMMITTEE AND CALL FOR NOMINATIONS FOR THEIR REPLACEMENTS

Further to circular N° ASR-01/2015, announcing the dates and venues of 2015 Africa regional scout events, this is to let you know that during the 16th Africa Regional Scout Conference in Uganda from 28th August to 1st September 2015, four (4) of the eight (8) current members of the Africa Regional Scout Committee will have completed their six-year term, which started in 2006 (ARTICLE VI, Points 1.a & b, Point 2.a and Points 3.a & b, of the Constitution of the Africa Scout Region).

The outgoing members are: Gilbert Mussumba (Chairperson, from Fédération des Scouts de la République du Congo), Bachir Mouhamadu Diouf (Vice-Chairperson, from Confédération Sénégalaise du Scoutisme), Jeanne Ebongue (member, from Les Scouts du Cameroun) and Ibrahima Cissé (member, from Association Nationale des Scouts de Guinée).

These outgoing members can only be eligible for re-election after a three-year lapse (ARTICLE VI: Point 1.c of Constitution of the Africa Scout Region).

In order to fill the resulting vacancies, nominations from member National Scout Organizations are being solicited. Should your National Scout Organization wish to nominate a member to the Africa Regional Scout Committee, please ensure that the attached nomination form is duly filled and submitted to the World Scout Bureau, Africa Regional Office no later than **28th May 2015** (ARTICLE VI: Points 3.a & b of the Constitution of the Africa Scout Region). The enclosed nomination form (16ASConf2015Doc1) must be completed by nominating National Scout organization and by each nominee, respectively.

Kindly note that no more than one elected member from any one member National Scout Organization may serve in the Africa Regional Scout Committee at any one period (ARTICLE VI: Point 1. b of the Constitution of Africa Scout Region). Therefore, candidates from the following member National Scout Organizations are not eligible to run for the 2015 elections, as each of them already has one sitting member on the Committee who will continue for another 3 years: Associação de Escuteiros de Angola, Ethiopia Scout Association, Mauritius Scout Association and Association des Scouts du Togo.
